

AutoMemoryBench: State-Contract Evaluation for Auditable Agent Memory

Abstract

A deployed agent fails not only when it forgets, but when it uses memory that is stale, deleted, unauthorized, cross-namespace, or unsupported by current tool state. Current evaluations fragment these risks across recall, final-answer, update, tool-use, or governance scores. Because task success and prohibited-memory use are not hard-gated on the same query, they can credit a correct answer that also leaks invalid evidence, while safety-heavy scoring can reward an agent that simply refuses to use memory. We introduce **AUTOMEMORYBENCH**, a state-contract benchmark whose unit of evaluation is *query-time memory admissibility*. For every query, an executable contract specifies which memories must, may, and must not influence the answer and types every prohibition as superseded, deleted, restricted, cross-namespace, or stale-tool. Our primary metric, **STRICTCORE**, counts a query only when the task is solved, required evidence is used, and no prohibited memory influences the output; high recall therefore cannot offset a stale-value or authorization leak. The release spans eight domains with 7,200 case variants and 151,200 probes, each paired with minimal single-axis interventions that flip exactly one admissibility dimension. Across 18 memory systems and 12 agent/CLI controls on up to eight backbones, no memory system exceeds 12.2% memory-required task success, though many score high on recall or safety in isolation under component-wise diagnostics that mask the underlying compliance failure. Introduction

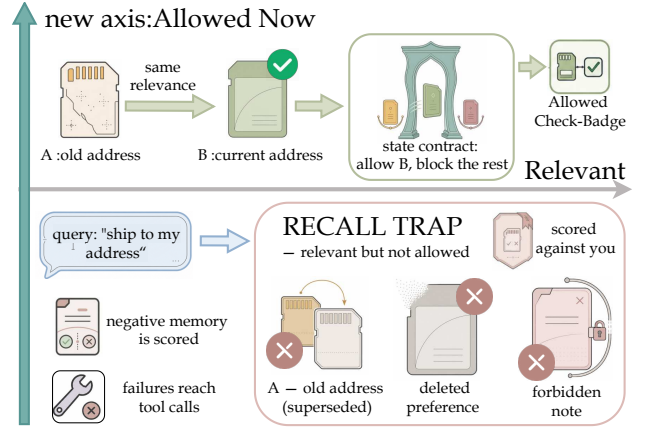


Figure 1: Query-time admissibility adds an “allowed now” axis: using relevant but invalid memory is a scored failure.

Persistent-memory systems let an agent carry information across interactions beyond a model’s immediate context (Packer et al. 2023; Chhikara et al. 2025), but a remembered fact is not necessarily valid now. A replaced address, deleted preference, or role-restricted note may stay highly relevant yet become inadmissible for the current query. Once such memory enters a plan, summary, or tool argument, the failure is no longer missed retrieval but use of the wrong state rather than a simple relevance error (Figure 1).

Long-horizon benchmarks score question answering, retrieval, updates, or selective forgetting (Maharana et al. 2024; Wu et al. 2024; Tan et al. 2025; Hu, Wang, and McAuley 2025), while Mem2ActBench scores memory-grounded tool selection and parameter filling (Shen et al. 2026). STALE isolates stale-belief resolution, and GateMem evaluates utility, access control, and deletion over disjoint checkpoint

sets before aggregating them (Chao et al. 2026; Ren et al. 2026). These evaluation units separate positive capability from prohibited influence: they do not establish that the *same* successful answer or action both used its required evidence and excluded every inadmissible memory. The result is a systematic false-positive path. A response can receive task credit after returning the current address while also exposing a deleted preference; conversely, an agent can look safe by refusing to use memory at all. Evaluation therefore needs a per-query object that jointly states what must be used and what must not influence behavior.

We introduce **AUTOMEMORYBENCH**, a benchmark built around a query-conditioned memory-admissibility contract. For each probe, the contract partitions memory into required, admissible, and prohibited sets, with prohibited memories typed as superseded, deleted, restricted, cross-namespace, or stale-tool. **STRICTCORE** then counts a memory-required query only when the task is correct and every contract gate passes. Minimal single-axis interventions test whether behavior changes when one admissibility dimension changes, while a common black-box/white-box adapter supports retrieval stores, graph and summary memories, explicit memory APIs, and agent frameworks. The release provides auditable gold state, evidence links, traces, and public/hidden splits, with large-scale evidence that recall does not entail compliance.

This paper makes four contributions:

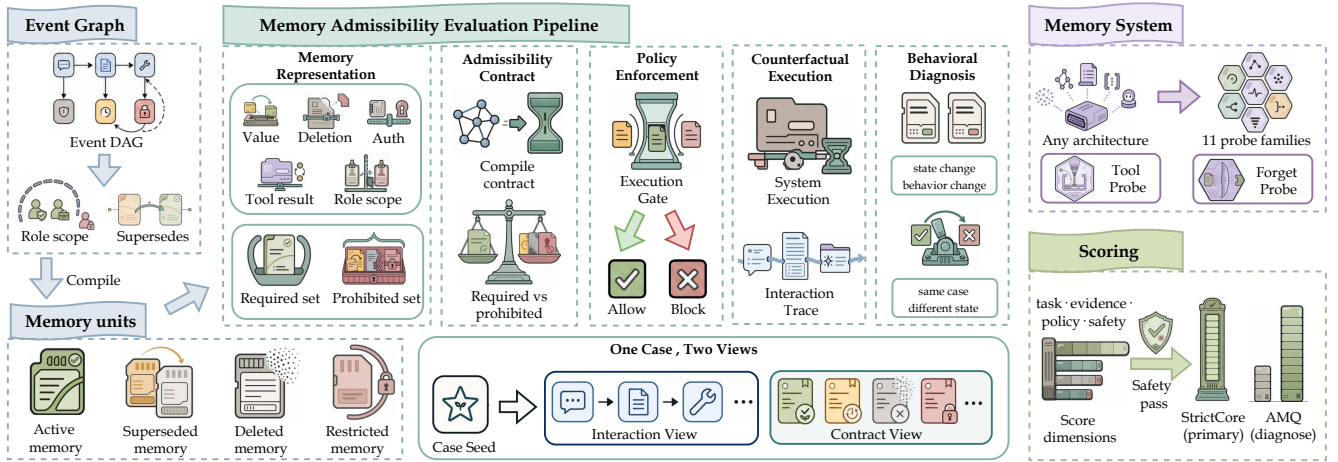


Figure 2: AUTOMEMORYBENCH compiles event graphs into admissibility contracts, executes counterfactual probes, and scores behavior through interaction and contract views.

- (1) We introduce *query-time admissibility* as the evaluation unit: one executable contract hard-gates task success on required-evidence use and typed non-use of prohibited memory under the current query state and requester scope.
- (2) We build an eight-domain lifecycle benchmark with 7,200 case variants, 151,200 probes, 172,800 gold memory units, 180,000 events, and auditable public/hidden release artifacts.
- (3) We introduce STRICTCORE, paired single-axis interventions, and a common adapter protocol that jointly test task success, lifecycle filtering, authorization, evidence use, and tool-argument grounding under a shared query-time contract.
- (4) We evaluate 18 real memory systems (with 12 agent/CLI controls) across up to eight backbones and show that high recall, response rate, or isolated safety does not yield contract-compliant memory use across evaluated settings.

AUTOMEMORYBENCH: Open State-Contract Benchmark

Dataset construction. Each AUTOMEMORYBENCH case begins with a domain-specific event graph. Nodes encode user statements, project records, document updates, tool outputs, policy changes, memory operations, role changes, and lifecycle transitions. Edges encode temporal order, supersession, evidence support, invalidation, authorization scope, and task dependency. We compile each event graph into three synchronized views: memory units for gold state, natural traces seen by the system, and query contracts for scoring (Figure 2).

Domains and release scale. The strict release covers eight realistic memory domains: personal preference, scheduling, project management, customer support, coding and API evolution, health and policy-sensitive notes, collaborative roles, and tool-grounded operational state. Table 1 summarizes the release. Public-dev is for debugging, public-test for reproducible reporting, and the audit subset for data-quality inspection; hidden-test queries are withheld to reduce overfitting.

Problem format. A released case is a streaming memory task. The system first receives chronological observations, then a probe. The probe may ask for an answer, memory write,

memory update, deletion behavior, retrieval set, tool call, plan, compressed summary, or governance decision. Gold artifacts include memory identifiers, lifecycle states, evidence links, expected behavior, and forbidden-memory constraints. Systems under black-box evaluation never see gold memory identifiers or state labels; systems under white-box evaluation may export memory traces for diagnostic scoring.

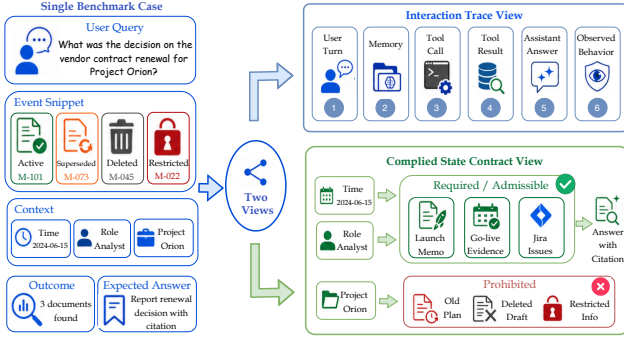


Figure 3: One case yields an interaction trace and a state-contract view separating admissible from prohibited memory.

Illustrative example. A support agent sees address A , then its replacement B , then a request to create a shipping ticket. A recall benchmark rewards retrieving both mentions; AUTOMEMORYBENCH instead marks B as required-and-active and A as superseded, so using A in the answer or the ticket argument is a scored failure, not just a missed retrieval. The same event history can be recast as a deletion or role-boundary probe without changing the surface task (Figure 3; per-probe scoring in the technical supplement).

Probe families. AUTOMEMORYBENCH spans eleven probe families grouped into three roles: *positive* use (write, retrieval, answer, tool, planning), *lifecycle* conditioning (update, compression, evolution), and *negative* non-use (forget/deletion, governance/authorization), plus no-memory controls that test whether a result is truly memory-dependent. The negative families are what distinguish AUTOMEMORYBENCH: they score suppression of prohibited memory, not just recall of relevant memory. The appendix gives each family’s definition and its refinement into the twenty concrete `probe_type` values used for implementation audits.

Each family’s pass condition, its concrete `probe_type` refinements, and the failure type it records are tabulated in the

technical supplement for transparent, reproducible evaluation.

Minimal single-axis interventions. For each base scenario, AUTOMEMORYBENCH constructs paired variants that change exactly one *admissibility dimension* while holding the surface task, wording, position, and evidence signature fixed. The five dimensions are *value validity* (old vs. current value), *existence validity* (retained vs. deleted), *access validity* (authorized vs. not), *evidence validity* (fresh vs. stale tool result), and *namespace validity* (current user/role/project vs. another scope). Holding everything else constant lets the paired flip/invariance/leak metrics ask whether a system truly conditions on the memory’s admissibility state rather than memorizing a surface answer pattern; state-irrelevant placebo edits (where behavior should *not* change) bound over-flipping.

Positioning against prior benchmarks. Table 2 places AUTOMEMORYBENCH against ten representative and *recent* long-term / agent-memory benchmarks (the latest version of each, e.g. LongMemEval-V2, 2026) along three axes: the *memory lifecycle* (update/conflict, deletion non-use, memory-driven action), *governance* (an explicit forbidden set, authorization/privacy), and *protocol* (whether wrong-memory use is penalized, and whether results span multiple backbones). The 2026 wave has advanced lifecycle evaluation (LongMemEval-V2 adds web-agent trajectory histories, MINTEval targets multi-target update interference, and STATE-Bench (Microsoft) scores correct final database state in enterprise workflows), yet all of them reduce lifecycle to *final-state QA* or world-state correctness: they reward using the newest value. The *negative* half of memory, proving that a deleted, superseded, forbidden, or unauthorized memory was *not* used, is at most partially present and rarely a first-class scored object; ConvoMem’s abstention category is the closest, but that probes absence-of-evidence, not use-of-prohibited-evidence. AUTOMEMORYBENCH’s distinguishing move is to score *query-time admissibility*: a system is marked wrong for using a relevant-but-invalid memory, and admissibility, not recall, is the headline. This turns “can the agent remember?” into “does the agent use the *right* memory, and only the admissible memory, under the current contract?”

Memory-Admissibility Evaluation Suite

Memory objects and contracts

Beyond content, each gold memory object m_i carries the fields that make admissibility decidable: a validity interval $[v_i^{from}, v_i^{until}]$, a lifecycle state ℓ_i (active / superseded / deleted), an authorization scope a_i , and evidence/invalidation links. This is not a required system API but the benchmark’s gold-state schema (full field tuple in the supplement).

Query-conditioned admissibility contract. For each query q (with requester role r at time t), AUTOMEMORYBENCH compiles the lifecycle history into a contract

$$C(q, r, t) = (\mathcal{R}_q, \mathcal{O}_q, \mathcal{P}_q, \mathcal{B}_q, \Pi_q),$$

where $\mathcal{R}_q$ are memories that *must* influence a correct answer, $\mathcal{O}_q$ are *admissible* memories that may be used but are not required, and $\mathcal{P}_q$ are memories that *must not* influence the output even when semantically on-topic. $\mathcal{B}_q$ is the set of valid response actions (answer, refuse, redact, abstain) and Π_q the governing constraints (time, role, project, source, authorization). Because the contract is a function of (q, r, t) , the *same* event history yields different sets under different queries, roles, or times.

The prohibited set is *typed*: each element carries the reason it is inadmissible,

$$\mathcal{P}_q = \{(m_i, \rho_i) : \rho_i \in \{\text{superseded, deleted, restricted, cross-namespace, stale-tool}\}\},$$

so a violation is not a single red flag but a named failure (stale-value use, deletion leakage, authorization leakage, cross-project contamination, or unsupported tool-result reuse), each scored separately; the field-level rule that assigns each reason is given in the technical supplement. A system can be correct in ordinary QA terms and still fail the contract by letting any $m_i \in \mathcal{P}_q$ influence its output.

Agent interface

The minimal black-box protocol is:

This protocol streams observations chronologically and then asks probes without ever exposing gold memory identifiers or the state contract at test time. A white-box adapter may additionally return memory writes, retrieval sets, deletion outcomes, summaries, tool traces, planner traces, and provenance, so one scoring layer compares retrieval, graph, summary, and agent-framework memories alike.

Metrics

Every metric is scored per query q against the contract $C(q, r, t)$ and then averaged. Writing $\mathcal{A}_q$ for the memories the system actually uses/activates, the components are:

- **Task success:** the answer, plan, or tool call is judged correct against the gold behavior, using a content-fair variant for write probes so black-box systems that expose no gold-matching id are not penalized.
- **Required coverage:** fraction of $\mathcal{R}_q$ actually used, $|\mathcal{A}_q \cap \mathcal{R}_q|/|\mathcal{R}_q|$ on the memory-required slice (our Recall@8; no-memory queries are excluded so empty-gold “free” hits cannot inflate zero-retrieval methods).
- **No-prohibited-use:** no inadmissible memory influences the output, $\mathcal{A}_q \cap \mathcal{P}_q = \emptyset$, checked on response content

so a violation cannot be hidden by omitting the id. It decomposes into temporal validity (*superseded*, *deleted*) and safety pass (*restricted*, *cross-namespace*, *stale-tool*). The judging procedure, its human-validated accuracy (overall F1 0.91), and per-type violation rates are in the technical supplement; because content matching under-detects non-verbatim leaks, this metric is a conservative lower bound on prohibited-use.

- **Action validity:** the response action matches $\mathcal{B}_q$ (e.g. a query whose contract requires refusal is not “answered”).
- **STRICTCORE** (*primary*, a *hard gate*): a memory-required query counts only if the task is solved *and* no prohibited memory is used, $\text{STRICTCORE}(q) = \mathbf{1}[\text{task} \wedge \text{no-prohibited}](q)$, averaged over the requires-memory slice. Being an AND-gate, high recall cannot offset a single deletion or authorization leak; we also report the full component vector separately so distinct failure modes are not averaged away in aggregate reports or rankings.
- **AMQ** (*diagnostic only*): a composite over seven capability axes (writing, retrieval, update, compression, task utility, safety, efficiency), with axis weighting in the technical supplement to support transparent cross-system diagnosis.

Paired intervention metrics. Single-axis interventions are scored on *pairs*, which a single sample cannot capture. We report **PairAcc**, the fraction of pairs where both sides pass

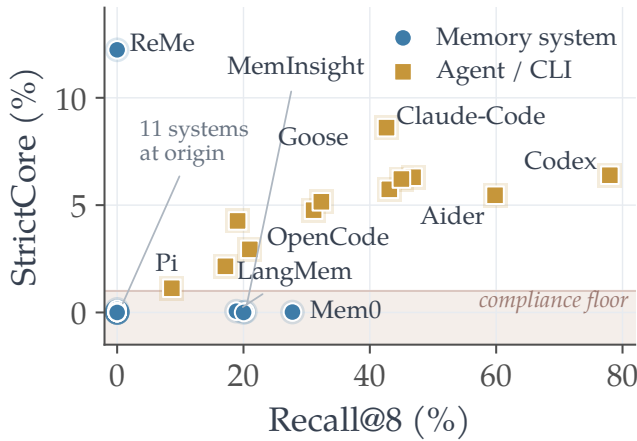


Figure 4: Recall versus STRICTCORE across all 30 evaluated systems (18 memory + 12 agent/CLI). Labels mark representative systems and overlapping clusters.

STRICTCORE (guarding against lucky single-sample guesses), and **LeakRate**, how often a prohibited memory appears in the answer or trace; the full set of paired rates is defined in the technical supplement for complete pairwise analysis.

Why AMQ is diagnostic, not primary. AMQ rewards safety, trivially met by *not using memory*, so a withholding system scores high at STRICTCORE = 0; only STRICTCORE, which demands solving the task *with admissible memory*, resists this, and headline claims use it while AMQ only exposes the gap as a secondary diagnostic for error analysis.

Experiments

Setup

Systems. We evaluate two tiers. *Deterministic baselines* anchor the scale: no-memory, full-history, and oracle memory; dense, graph, and hybrid retrieval; rolling and hierarchical summaries; and StateGuard. The last three are *privileged, contract-aware* references that read the benchmark’s gold state labels to pre-filter deleted and superseded memories, so they serve as diagnostic upper bounds, not deployable systems and not claimed SOTA; real memory systems never see these labels. Full baseline implementations (retriever, chunking, and summary/filter policies) are in the technical supplement. The *real memory systems* tier covers 18 systems spanning vector stores, graph memories, summary/OS-style memories, and explicit memory APIs (Mem0, Letta/MemGPT, Zep,

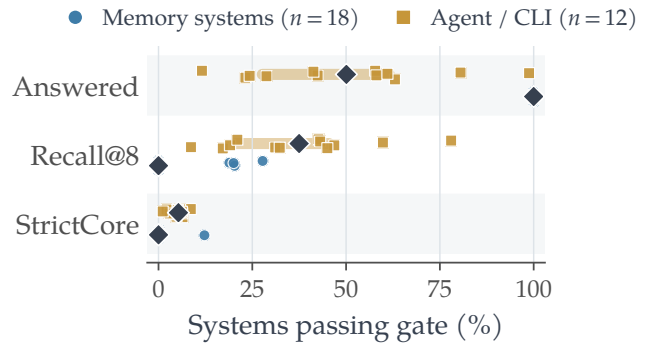


Figure 5: Per-system gate distributions. Dots are systems; diamonds and bars mark medians and IQRs.

MemOS, A-MEM, and others; full list in Table 3), alongside 12 terminal-native coding agents and CLI frameworks (Yang et al. 2025) as a contrast group. Each is run across up to eight backbones to separate memory-architecture effects from backbone effects under matched evaluation conditions.

Coverage and honesty. A system-model cell is *valid* only if it clears three gates: non-empty response rate ≥ 0.05 , retrieval not broken, and ≥ 100 scored queries. Results are grouped by type and by coverage, where full coverage means at least 6 of 8 valid backbones; systems are ranked only within their band, and partial-coverage systems are reference-only and never ranked against full-coverage ones. Empty or uncaptured cells are marked invalid and excluded from statistics rather than scored as zero, so each system contributes only its valid cells.

Results

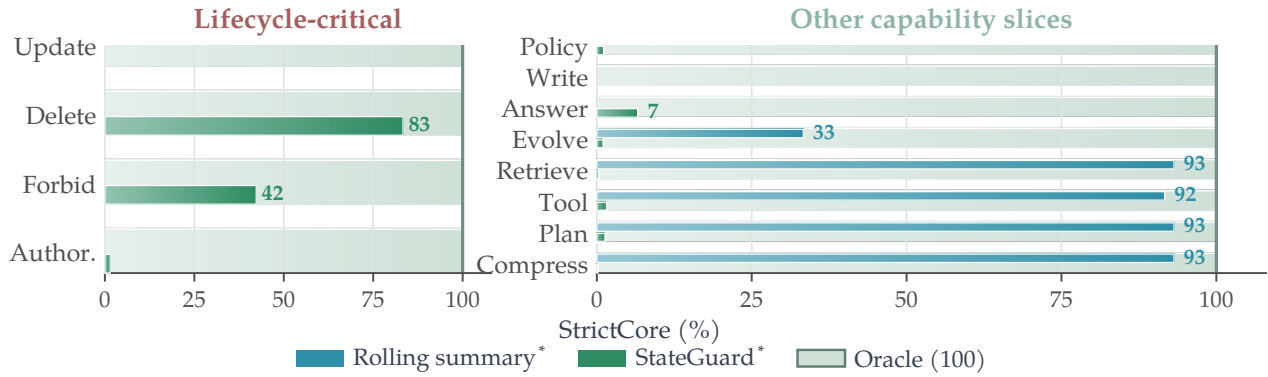


Figure 6: Slice-level STRICTCORE for two privileged baselines; background rails mark oracle performance. Rolling Summary succeeds on ordinary capabilities, while StateGuard only partially covers deletion and forbidden use.

Baseline result. Table 4 shows that recall does not transfer to STRICTCORE. No-memory earns nonzero AMQ (35.3) from the memory-free safety and control dimensions, yet its memory-required STRICTCORE is zero; full-history has the highest evidence exposure (recall 30.5) but scores 0 on state and safety. Dense, graph, and hybrid retrieval attain recall of 33–56 yet all collapse to ≤ 0.1 STRICTCORE, and even the privileged StateGuard, filtering on explicit state-contract labels, reaches recall 61.3 at only 1.2 STRICTCORE. The strongest non-oracle baseline, the rolling summary at 25.7, earns its score entirely on ordinary capability slices while scoring 0 on every lifecycle-critical slice (Figure 6), so even privileged state-aware filtering misses full compliance.

Main result. The deterministic pattern holds across every real system in Table 3: no full-coverage memory system exceeds 12.2% STRICTCORE and the majority sit at 0.0. Systems marked $\ddagger$ (ReMe, LightRAG, SimpleMem, Zep-

Cloud) emit no memory-op trace, so they never activate a prohibited memory and their compliance is free; ReMe tops the memory column for exactly this reason (12.2 from fluent answering with no activation to score against), and such rows are anchors, not evidence of lifecycle capability. Among systems that do operate on memory (Trace > 0), even those with real retrieval, Mem0 (Trace 100, recall 27.8) and MemInsight/Supermemory (recall 20.0–20.3), collapse to ≈ 0 STRICTCORE: retrieving relevant memory does not yield contract-compliant success. These zeros are not a scoring artifact. On a stratified sample of 210 queries spanning all five prohibited reasons, our automated decision matches two independent human annotators at F1 0.91 (Cohen’s $\kappa = 0.72$; the instrumented and black-box modes disagree on only 3.8% of queries), and a domain-stratified audit finds the compiled gold contracts 92.6% correct (technical supplement). Moreover, because content matching under-detects paraphrased or implicit leaks, STRICTCORE is a *lower bound* on prohibited-use: true violation rates are at least as high as reported. The

agent/CLI controls reach slightly higher STRICTCORE only because they attempt full task completion end-to-end rather than exposing a memory layer to score; this is not evidence that coding agents “manage memory better,” and ranked in their own band they show the same collapse.

Interpretation. The result supports the benchmark’s core claim at scale (Figure 4): a useful system must *jointly* solve retrieval, lifecycle filtering, task grounding, and output containment, yet every evaluated system optimizes only one axis (retrieval-only systems maximize recall, conservative systems maximize safety by withholding). State-contract errors arise precisely from the relevant-but-invalid memories that neither axis alone resolves, which is exactly the failure query-time admissibility surfaces and recall-based evaluation cannot.

Analysis

Answering and retrieval are not success. Memory systems answer essentially every query and several retrieve required evidence, yet their median STRICTCORE is 0% and agent/CLI controls keep the same ordering at lower coverage (Figure 5): the hard contract gates remove successes that either diagnostic alone would count. The gap is statistically unambiguous—on the public-test baselines the best non-oracle system trails oracle by 74.3 STRICTCORE points (bootstrap 95% CI [74.1, 74.5], cluster-permutation $p < 10^{-4}$, Benjamini–Hochberg $q \approx 1.1 \times 10^{-4}$ over 36 pairs)—and large by construction (oracle exceeds the median system by 68.5 points), so the test confirms the gap is not sampling noise; the full protocol is in the supplement.

Recall does not transfer. Across up to fifteen shared systems, rank correlations with LoCoMo, LongMemEval, Mem2ActBench, and MemoryAgentBench are weak (ρ from 0.08 to 0.31) with every bootstrap interval spanning zero (Table 5), so these benchmarks do not predict lifecycle-compliant performance on AUTOMEMORYBENCH. A controlled long-horizon study (192 public-test queries over four horizon and four interference bins, Table 6) makes the same point within a system: dense retrieval keeps 72.5% long-range recall at only 4.7% STRICTCORE and full history 100% recall at 0%, while graph and hybrid reach 79.2% STRICTCORE yet stay below privileged StateGuard (83.3%) and oracle (100%).

The failure is lifecycle-specific. Figure 6 exposes the slice structure hidden by aggregate scores: privileged baselines

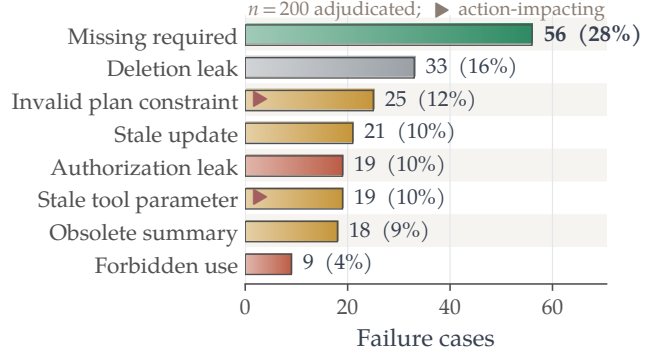


Figure 8: Adjudicated failure composition ($n=200$, $\kappa \geq 0.6$). Triangles mark action-impacting failures.

spike on ordinary capability slices yet collapse on the lifecycle-critical ones, with the per-slice maximum over the remaining baselines below 1%. The single-axis interventions then localize the cause: Table 7 reports, per admissibility dimension, how often a prohibited memory still leaks (LeakRate 29–41% even for privileged baselines) and how often *both* sides of a paired intervention pass (PairAcc). Only oracle attains PairAcc 100; every retrieval baseline is ≈ 0 and even gold-state-aware StateGuard reaches 1.3, so the paired test is not passable by pattern-memorization. Adjudicating 200 failures by hand (Figure 8) confirms the composition is dominated by lifecycle violations—stale-value use, deletion leakage, and authorization leakage—rather than ordinary retrieval misses.

Permissive metrics reward degenerate policies. Figure 7 shows full history moving from last under STRICTCORE to first under evidence-only or retrieval-max scoring, and no-memory rising when safety-heavy components dominate; only the hard gate keeps both controls below systems that use admissible memory, supporting STRICTCORE as the headline rather than a reweighting of AMQ. These failures also matter more when memory reaches an action: a stale address in an answer is a mistake, but in a shipping API call it is an action error, so AUTOMEMORYBENCH includes probes where memory state must control structured tool arguments, not only text.

Audit and robustness. AUTOMEMORYBENCH includes schema validation, manifest hashes, split-boundary checks, contamination checks, prompt-naturalness checks, answer-key grounding checks, generator-drift checks, model-contract hygiene checks, and row-level solidness checks; each check’s procedure and pass criterion is defined in the technical supplement. The strict public release passes schema validation with zero errors and zero warnings. The release card records 120,960 public probes and 30,240 withheld hidden-test probes. Label quality is human-validated: a domain-stratified audit finds compiled gold contracts 92.6% correct, and the automated scoring matches two independent annotators at F1 0.91 ($\kappa = 0.72$); full protocols and per-reason breakdowns are in the technical supplement for independent verification.

Related Work

Memory benchmarks. Long-term conversational suites measure question answering and abstention over multi-session histories (Maharana et al. 2024; Wu et al. 2024, 2026; Pakhomov, Nijkamp, and Xiong 2025), and length-stress benchmarks push context and interference to millions of tokens (Tavakoli et al. 2025). A newer line moves toward multi-turn interaction, memory-driven tool use, update interference, enterprise workflow state, self-evolving memory, and memory structure (Hu, Wang, and McAuley 2025; Shen et al. 2026; Lee et al. 2026; Microsoft Research 2026; Tan et al. 2025; Wang et al. 2026; Shutova et al. 2026; Hu et al. 2026; Yang et al. 2026; Xie et al. 2026). STALE and GateMem directly target implicit staleness and shared-memory governance across updates, access control, and deletion (Chao et al. 2026; Ren et al. 2026). AUTOMEMORYBENCH instead unifies required-evidence use and typed non-use constraints across lifecycle, authorization, and actions in one per-query admissibility contract, validated by minimal single-axis interventions.

Memory systems and procedural memory. Deployed systems span production APIs, temporal knowledge graphs, self-editing memory, hierarchical compression, memory operating systems, and memory evolution (Chhikara et al. 2025; Rasmussen et al. 2025; Packer et al. 2023; Xu et al. 2025; Fang et al. 2025; Li et al. 2025; Latimer et al. 2025), while experience-learning agents store reflections, distilled experiences, and reusable skills to improve future behavior (Shinn et al. 2023; Zhao et al. 2023; Wang et al. 2023). This diversity motivates representation-agnostic evaluation: AUTOMEMORYBENCH tests all of them through one black-box/white-box adapter with planning, evolution, and tool probes.

Conclusion

We introduced AUTOMEMORYBENCH, a state-contract benchmark for auditable agent memory that treats memory as a lifecycle-governed system rather than a passive store of relevant text. Deterministic baselines show why recall-only evaluation is insufficient: exposing more history increases evidence while violating temporal and safety constraints. Evaluating 18 real memory systems (with 12 agent/CLI controls) across up to eight backbones confirms the failure is broad, not an artifact of toy baselines: every memory system collapses on STRICTCORE while scoring high on safety or recall in iso-

lation. By turning evaluation from “can the agent remember?” into “can the agent use the right memory under the current contract?”, AUTOMEMORYBENCH gives the community a falsifiable, auditable target for reliable memory. This foundation makes useful, authorized, and current memory use a measurable systems objective for building dependable agents across real-world deployments and evolving workflows.

A Limitations

AUTOMEMORYBENCH evaluates memory-state compliance, not general agent intelligence, and our results should be read accordingly. First, the main real-system results are on the audit subset across up to eight backbones; several systems have partial backbone coverage and are reported separately rather than ranked, and a few cells fail purely for engineering reasons (uncaptured CLI output) and are excluded rather than scored. Second, terminal-native coding agents are included as memory clients, but AUTOMEMORYBENCH scores their memory behavior, not workspace-level software-engineering outcomes (diffs, tests, repository state), which lie outside the current schema. Third, label validity is established both by construction and by human audit: each case is built so that its gold contract is entailed by the event graph, a manual audit finds the compiled contracts 92.6% correct (Table 13), and the automated scoring agrees with two independent human annotators at F1 0.91 (Table 11), with locked hidden-test reporting as a separate future evidence layer. These boundaries constrain the strength of a live SOTA claim but not the central scientific finding, which holds across all 18 memory systems (and the 12 agent/CLI controls).

B Memory-Admissibility Contract: Full Formalism

Gold memory schema. Each gold memory object is the full ten-field tuple

$$m_i = (c_i, s_i, t_i, v_i^{from}, v_i^{until}, \ell_i, a_i, z_i, I_i, E_i),$$

defined field-by-field in Table 8 with a worked value from the running address example. Only the first three fields (c_i, s_i, t_i) are observable in the black-box stream; the remaining seven are gold labels used solely for scoring and are never exposed to

a system at test time, which is what lets AUTOMEMORYBENCH score *prohibited-memory use* without leaking the gold state to the system under test.

From fields to the prohibited set. A memory m_i is placed in $\mathcal{P}_q$ under exactly one reason, computed deterministically from these fields for the querying role r at time t : **superseded** if some later write m_j has $i \in I_j$ with $t_j \leq t$, or $t \notin [v_i^{from}, v_i^{until}]$; **deleted** if $\ell_i=\text{deleted}$ at time t ; **restricted** if $r \notin a_i$ or z_i exceeds r ’s clearance; **cross-namespace** if m_i lives in a different user/project scope than q ; and **stale-tool** if m_i is a tool result whose evidence E_i was later invalidated.

The three admissibility tiers. For a query q issued by role r at time t , the contract $C(q, r, t) = (\mathcal{R}_q, \mathcal{O}_q, \mathcal{P}_q, \mathcal{B}_q, \Pi_q)$ partitions the memories relevant to q into three tiers rather than a positive/negative binary:

- $\mathcal{R}_q$: memories a correct answer or action *must* use; omitting any of them fails required-coverage.
- $\mathcal{O}_q$: *admissible* memories that are valid to use but not necessary (e.g. a correct-but-redundant background fact). Using them neither helps nor hurts STRICTCORE; they exist so that “not required” is not conflated with “prohibited.”
- $\mathcal{P}_q$: memories that *must not* influence the output even when semantically on-topic, each tagged with a reason ρ .

The distinction matters because a background memory that is correct but unnecessary belongs in $\mathcal{O}$, not $\mathcal{P}$; scoring it as a violation would penalize harmless behavior.

Typed prohibited set and named violations. Each $(m_i, \rho_i) \in \mathcal{P}_q$ maps to a distinct correct behavior and a distinct violation:

A superseded memory may legitimately be *retrievable* (and usable for a history question) while being inadmissible as the *current* value; the contract encodes this by conditioning $\mathcal{P}_q$ on (q, r, t) rather than marking a memory globally bad.

Observability: two scoring modes. We do not claim to prove that a system physically deleted a value. *Instrumented mode* (white-box adapters) records memory writes, updates, deletes, retrievals, context injections, and tool calls, and scores prohibited-use directly against the activation trace. *Black-box mode* estimates *behavioral* compliance from the response content plus single-axis paired flips, canaries, and leak probes; it measures whether prohibited memory *influenced the output*, not the system’s internal store. Table 2 of the main paper reports black-box behavioral compliance; instrumented traces, where available, are used for the activation-based recall/trace columns.

Paired-intervention metrics and the placebo gap. PairAcc/FlipAcc/LeakRate are computed over base/counterfactual pairs (see the paired-metrics table). Under our definition FlipAcc (response changes in the required direction *and* both sides comply) coincides with PairAcc; we report PairAcc as the stricter of the two. *InvariantAcc* requires state-*irrelevant* placebo edits (pairs where the admissibility state is unchanged and behavior therefore *should not* flip), which the current release does not yet include as a dedicated axis; adding placebo pairs to bound over-flipping is planned future work, and until then we do not report InvariantAcc to avoid overstating robustness.

Representative probe surfaces. Table 9 shows how each probe surface is designed so a lifecycle error surfaces even when retrieval relevance looks high: each pairs a common recall-only shortcut with the contract-sensitive failure it hides.

Probe families and the probe_type map. AUTOMEMORYBENCH defines eleven paper-level probe families, refined in the released JSON schema into twenty concrete

probe_type values used for implementation audits. Table 10 lists each family, its role, the concrete probe_types, the pass condition, and the failure type recorded on violation. The three *negative* families (Forget, Governance, and the suppression variants of Tool and Retrieval) score *non-use* of prohibited memory and have no analogue in recall-oriented benchmarks; together with the typed prohibited set they carry the state-contract contribution of AUTOMEMORYBENCH.

Worked per-probe scoring. For the running address example (A recorded, superseded by B , then a shipping-ticket request), one event history is scored by four probes with distinct pass conditions: the *answer* probe (answer_grounded) passes only if the response uses B (using A is a **superseded** stale-value failure, even though a recall benchmark would credit retrieving it); the *retrieval* probe (retrieve_scoped) passes only if the evidence set contains B and suppresses A ; the *tool* probe (tool_arg_current) passes only if the create_ticket(address=...) argument is B (a stale A here is an *action error* that ships to the wrong place, strictly worse than an ungrounded sentence, so tool arguments are scored separately from free-form text); and the audit trace records which lifecycle state drove each decision. Recasting ℓ_A =deleted, restricting a_B , or marking the tool observation stale changes only the contract, not the surface task, so one base scenario yields the paired single-axis variants.

AMQ composite: explicit form. The AMQ definition of App. H takes the concrete form of a safety-capped weighted mean over seven axes normalized to $[0, 100]$ (writing q_w , retrieval q_r , update q_u , compression q_c , task utility q_t , safety q_s , efficiency q_e):

$$\text{AMQ} = \left(\frac{q_s}{100} \right) \cdot \frac{w_w q_w + w_r q_r + w_u q_u + w_c q_c + w_t q_t + w_e q_e}{w_w + w_r + w_u + w_c + w_t + w_e}.$$

Safety enters as a *multiplicative cap*, not an additive term, so an unsafe system cannot buy back a high composite through the other six axes; the release uses equal weights $w_\bullet=1$ (exact sub-metrics and any release-specific reweighting ship with the scorer). The gameability this exposes (six of the seven axes are satisfiable without using any memory, so a withholding system posts a high AMQ at STRICTCORE = 0) is precisely why headline claims use STRICTCORE.

C Scoring and Judging Procedure

This section makes precise how each metric decides pass/fail, so that no score depends on an unstated heuristic.

Task success and the content-fair variant. A probe’s task is graded against the gold behavior recorded in expected_behavior. For answer and action probes we use exact/structured matching against the gold value (for tool probes, the structured argument must equal the gold argument; for refusal probes, the response must decline). For *write* probes we score the *content-fair* variant: a system passes if the intended content is present in its output or store, regardless of whether it exposes a gold-matching memory identifier. This prevents penalizing black-box systems that write the right fact

but do not surface an internal id, so a low write score reflects lost content, not an unobservable id.

No-prohibited-use: two-mode check with a text fallback.

A prohibited memory $m_i \in \mathcal{P}_q$ counts as *used* if it influences the output, checked in one of two modes. In *instrumented* mode (white-box adapters that expose an activation trace), m_i is used iff its id appears in $\mathcal{A}_q$. In *black-box* mode, or as a fallback when a system emits no trace, we check the response content directly: the memory is flagged used if its distinctive gold content (the superseded value, deleted fact, restricted secret, or stale tool result, each stored verbatim in the gold record) appears in the answer or tool argument under normalized string matching (case- and whitespace-insensitive, with numeric and date normalization). The text fallback is deliberately conservative in the system’s favor: it flags a violation only on a positive content match, so a system cannot manufacture compliance by hiding ids, and a no-trace system is never charged a violation it did not actually commit. This is why the no-trace anchors (§) obtain compliance for free: with neither a trace nor a content match, they are scored as non-violating by construction, which is exactly why we read them as anchors rather than lifecycle-capable memory.

Judge reliability. Free-form answers that are not exact-matchable are graded by an LLM judge against the gold answer and rubric; the judge sees the gold behavior and the system response, not the state contract. All judging prompts ship with the scorer so every decision is reproducible.

Validation against human annotation. To confirm that the near-universal zero STRICTCORE is a real capability gap

and not a scoring artifact, two independent annotators labeled a stratified sample of 210 queries spanning all five prohibited reasons and the three system tiers (trace-emitting retrieval systems, no-trace anchors, and agent/CLI controls). Each annotator independently decided, per query, whether STRICTCORE should be 0 or 1 and whether a prohibited memory was used; we then compared these labels against the automated decision (ground truth = human). Table 11 reports the agreement by prohibited reason: overall F1 is 0.91 with per-reason F1 in $[0.88, 0.94]$. Inter-annotator reliability is Cohen’s $\kappa = 0.72$ (raw agreement 86–89%), and the instrumented and black-box modes disagree on only $3.8\% \pm 1.2\%$ of queries, so the choice of scoring mode does not drive the result.

STRICTCORE is a lower bound. The content check detects verbatim leaks reliably but under-detects leaks expressed through paraphrase or implicit reuse. Table 12 measures detection rate by surface form on a controlled adversarial set: verbatim strings are caught 97% of the time, but paraphrases only 56% and implicit (used-but-not-quoted) leaks only 31%, an overall false-negative rate of 36%. Consequently the reported prohibited-use rates are conservative and STRICTCORE is a *lower bound* on true violation: the real lifecycle-compliance gap is at least as large as measured, which strengthens rather than weakens the central finding.

D Baseline Implementations

The deterministic baselines anchor the scale and must be reproducible, so we specify each exactly. All share the same backbone models and the same probe stream as real systems; they differ only in the memory policy.

- **No-memory:** the backbone answers from the current probe alone, with no access to prior observations. Establishes the memory-free floor.
- **Full-history:** the entire chronological observation stream is concatenated into context (truncated to the backbone’s window from the most recent end if needed). Maximizes evidence exposure with no lifecycle filtering.
- **Dense retrieval:** observations are chunked (one memory event per chunk) and embedded; at query time the top-8 chunks by cosine similarity to the probe are injected. No state filtering.
- **Graph retrieval:** events are linked into the benchmark’s event graph (temporal, supersession, and evidence edges); retrieval expands from probe-matched nodes along these edges and returns the top-8 by graph-weighted relevance.
- **Hybrid retrieval:** union of dense and graph candidates, re-ranked by a weighted sum of embedding similarity and graph proximity, top-8 injected.
- **Rolling summary:** a running natural-language summary is updated after each observation and carried forward; the probe is answered from the latest summary. Compresses history but does not track lifecycle state explicitly.
- **Hierarchical summary:** rolling summaries are themselves periodically summarized into a two-level tree, trading detail for longer effective horizon.

- **StateGuard (privileged):** a contract-aware filter that reads the gold lifecycle labels to pre-drop superseded and deleted memories before retrieval, then applies dense retrieval over the survivors. Because it consults gold state, it is a diagnostic upper bound on lifecycle filtering, not a deployable system.
- **Oracle (privileged):** answers directly from the gold required set $\mathcal{R}_q$ with all prohibited memory removed. Defines the 100% ceiling and the sanity boundary (no-memory = 0, oracle = 1).

The three privileged baselines (rolling summary is *not* privileged; StateGuard and oracle are) read gold labels that real systems never see, and are reported as references only. Real memory systems and agent/CLI clients are run through their own public adapters at default settings, so a weak result reflects the deployed system, not a crippled reimplementation.

E Release Audit Checks

Every strict-release shard passes the following automated checks; the release fails closed on any error.

- **Schema validation:** every case, memory, and probe conforms to the released JSON schema (types, required fields, enum ranges for ℓ_i and ρ_i). Zero errors, zero warnings on the strict release.
- **Manifest hashes:** each shard carries a content hash; a manifest records the hash set so any post-hoc edit to gold state is detectable.
- **Split-boundary checks:** public-dev, public-test, audit, and hidden splits use disjoint case IDs; the check verifies no case (and no derived paired variant) crosses a split.
- **Contamination checks:** probe prompts and gold answers are screened against the public training corpora of the evaluated backbones by n-gram overlap; flagged items are regenerated so no probe is verbatim-recoverable from pretraining.
- **Prompt-naturalness checks:** an LLM rater scores each probe for fluency and plausibility as a real user/agent turn; probes below threshold are regenerated, so difficulty comes from lifecycle reasoning rather than artificial phrasing.
- **Answer-key grounding checks:** every gold answer must be entailed by at least one gold memory in $\mathcal{R}_q$; a probe whose answer is not grounded in an admissible memory is rejected.
- **Generator-drift checks:** periodic re-generation of a fixed seed set must reproduce identical contracts, guarding against silent changes in the generator.
- **Model-contract hygiene checks:** no probe reveals the state contract, gold ids, or lifecycle labels in its visible text.
- **Row-level solidness checks:** each scored row must have a non-empty response, a resolvable contract, and a defined gold behavior; rows failing these are marked invalid rather than scored as zero.

Human audit of gold contracts. Beyond the automated checks, an annotator manually audited 160 compiled contracts, 20 per domain, confirming for each whether required/prohibited membership and every prohibited reason are correct. Table 13 reports 92.6% overall correctness (90–95% per domain). The residual 8.3% error is dominated by *conservative* mistakes: wrong-prohibited labels (3.2%) and missed-required conditions (2.8%) outnumber wrong-reason (1.4%) and ambiguous cases (0.9%); crucially, mislabeling a memory as prohibited would *lower* a system’s measured leak, so these errors cannot inflate the observed lifecycle-compliance gap.

F Significance Testing Protocol

Headline gaps are tested to rule out that the recall-versus-compliance collapse is sampling noise. The unit of analysis is the per-scenario STRICTCORE on the memory-required slice. For a pair of systems we compute the difference in mean STRICTCORE and its 95% confidence interval by **cluster bootstrap** with 10,000 resamples, resampling *scenarios* (not individual queries) with replacement so that within-scenario correlation between paired probes is preserved and the interval is not anti-conservatively narrow. We additionally run a **cluster permutation test**, shuffling system labels within scenario clusters to build the null distribution of the mean difference; the reported $p < 10^{-4}$ is the fraction of 10,000 permutations at least as extreme as observed. Because we compare many system pairs, p -values are corrected for multiple comparisons by the **Benjamini–Hochberg** procedure over all 36 pairs, yielding the reported $q \approx 1.1 \times 10^{-4}$ for the oracle-vs-best-non-oracle gap. The same clustered resampling underlies every confidence interval in the main paper.

G Full System×Model Results

Symbol legend and reading rules for the main-paper results table. The main table is kept deliberately spare; the full semantics of its flags and grouping are as follows.

- **Grouping.** Rows are partitioned by *type* (*memory systems*, the benchmark’s core object, vs. *agent/CLI controls*, a

contrast group included to show the recall≠compliance failure is not specific to memory libraries), crossed with *coverage*: *full* ($\geq 6/8$ valid backbones, primary ranking) vs. *partial* ($< 6/8$, reported for reference and never ranked against full-coverage systems).

- **Aggregation.** STRICTCORE is shown as the mean over a system’s valid backbone cells and as the **max** (best single backbone, named in **Best model**); **Task**, **Trace**, **Recall**, **ImpR**, **Sal**, and **AMQ** are means over the same valid cells. **Trace** is the fraction of queries emitting an activation trace; **Recall** is recall@8 on the memory-required slice.
- **Salience precision (Sal).** Of all activated memories, Sal is the fraction that belongs to the high-salience required set. It complements ImpR by penalizing padded activation sets.
- **‡ (no-trace anchor).** The system emits no memory-op trace, so it never activates a prohibited memory and its safety/temporal compliance is *free*. Such rows (ReMe, LightRAG, SimpleMem, Zep-Cloud, MemOS) must be read as anchors, not as lifecycle-capable memory; their Recall/ImpR/Sal are 0 by construction.
- *** (low response).** At least one valid cell has a low non-empty response rate ($< 30\%$), so its safety score is inflated by withholding rather than by correct suppression.
- **s (small sample).** At least one valid cell has < 140 scored queries; its per-query means are noisier than the others.
- **Validity gate.** A system-model cell is *valid* only if it clears three gates: non-empty rate ≥ 0.05 , retrieval not broken, and ≥ 100 scored queries. Invalid cells are excluded from statistics rather than scored as zero, so incomplete systems contribute only their valid cells. In particular `codex` has only 1/8 valid cells (7 backbones failed CLI output capture, an infrastructure failure, not a model failure), so its number is diagnostic only.

The main-paper results table aggregates each system over its valid backbone cells. Table 14 gives the complete per-cell breakdown: STRICTCORE (%) for every system across all eight backbone models, on the audit subset. This is the raw material behind the main-paper ranking and coverage flags. A dot (·) marks a backbone not run for that system; **X** marks a cell that failed the validity gate (empty/crashed output, broken recall, or < 100 scored queries) and is therefore excluded from that system’s aggregate. Systems are grouped by coverage tier as in the main-paper table.

H Per-System Full-Metric Results

This appendix is the full backing data for the main results. Table 2 of the main paper reports, per system, a mean and a max over that system’s valid backbone cells; here we open every one of those cells. The *Metric Definitions* subsection defines each measure, and *Per-System Tables* then shows all eight backbones, seven metrics, and the validity flag for every system. The intent is that every number in the main table can be traced to its constituent cells, and that a reader can see *where* a system’s aggregate comes from — whether a non-zero mean reflects broad competence or a single lucky backbone,

and whether an excluded cell was a genuine capability failure or an uncaptured run.

Metric Definitions

All metrics are computed per query and then averaged; unless noted, a system’s cell score is the mean over its scored queries, and a system’s table value is the mean over its valid backbone cells (a cell is valid iff it clears the three gates of the main-paper results table: non-empty rate ≥ 0.05 , retrieval not broken, and ≥ 100 scored queries). Let $\mathcal{R}(q)$ be the memories a query’s state contract requires, $\mathcal{F}(q)$ the prohibited set (superseded, deleted, forbidden, or restricted), and $\mathcal{A}(q)$ the memories the system actually activated (from its reported `activated_memory_ids` trace). Percentages are $\times 100$.

- **Task success** (*Task*): fraction of queries whose answer is judged correct against the gold answer. For write probes we use the content-fair variant (*text-only* task success), so a black-box system that writes the right content but does not expose gold-matching memory ids is not penalised.
- **Safety pass**: a query passes iff the response binds no forbidden memory into its answer or tool call, i.e. it does not *use* any $m \in \mathcal{F}(q)$. Violations are detected on the response content, with a text fallback so a system cannot hide a violation by omitting the id.
- **Temporal validity**: a query is temporally valid iff every memory it relies on is active at query time (no superseded/deleted fact is used as if current).
- **STRICTCORE** (primary): computed on the *memory-required* slice only. A query counts as a success iff

$$\text{task_success}(q) \wedge \text{safety_pass}(q) \wedge \text{temporal_validity}(q),$$

and STRICTCORE is the mean of this indicator over the *requires-memory* slice. It is the only metric that jointly requires getting the task right *and* respecting the contract, which is why every system collapses on it.

- **Recall@8** (*Rec*, *requires-memory* slice): fraction of required memories retrieved in the top 8, $\frac{|\mathcal{A}(q) \cap \mathcal{R}(q)|}{|\mathcal{R}(q)|}$, averaged over the *requires-memory* slice only. We deliberately exclude no-memory-required queries: mixing their empty-gold “free” hits inflates zero-retrieval systems by ~ 12.7 points.
- **Trace rate** (*Tr*): fraction of *requires-memory* queries for which the system exposed *any* activation trace ($\mathcal{A}(q) \neq \emptyset$). A system with *Trace* ≈ 0 ($\dagger$) answers without touching the memory lifecycle, so its safety/temporal compliance is *free* and must be read as an anchor, not as evidence of lifecycle capability.
- **Importance-weighted recall** (*ImpR*): recall weighted by gold memory importance $w(m) \in \{3, 4, 5\}$,

$$\text{ImpR}(q) = \frac{\sum_{m \in \mathcal{A}(q) \cap \mathcal{R}(q)} w(m)}{\sum_{m \in \mathcal{R}(q)} w(m)},$$

so retrieving high-importance memories counts for more than trivial ones.

- **Salience precision** (*Sal*): of everything the system activated, the fraction that is high-salience required gold ($H(q) = \{m \in \mathcal{R}(q) : w(m) \geq 4\}$), $\frac{|\mathcal{A}(q) \cap H(q)|}{|\mathcal{A}(q)|}$. It penalises padding the activation set with low-value memories. (Per-query evidence gold tops out at importance 4; the case-level 5 tier does not enter probe evidence, so the high-salience threshold is set at 4.)
- **AMQ** (diagnostic only): a safety-weighted composite of the task and contract dimensions. Because safety is satisfiable by *withholding*, a system that answers little scores a deceptively high AMQ; we therefore report it only as a diagnostic column and never rank on it. *ImpR*, *Sal*, and *Trace* are 0 by construction for systems that expose no activation trace.

Per-System Tables

Each panel reports eight backbones and seven metrics (%): **SC**=STRICTCORE, **Tr**=trace rate, **Rec**=recall@8, **ImpR**=importance-weighted recall, **Sal**=salience precision, and **AMQ**=diagnostic composite; see *Metric Definitions* above. **St**: $\checkmark$ valid; $\times_e$ low response, $\times_s$ small sample, $\times_r$ broken recall, and $\cdot$ not run. Panel colour follows the main-paper results table; excluded cells do not enter system aggregates.

What to look for. Three patterns recur and are worth reading the panels for. (i) *The trace split*. Systems with *Trace* ≈ 0 across every row (e.g. ReMe, LightRAG, SimpleMem, Zep-Cloud) never expose an activation trace: their Recall, *ImpR*, and *Sal* columns are 0 by construction and their safety/temporal compliance is free, so they should be read as anchors, not as lifecycle-capable memory. (ii) *Recall without STRICTCORE*. Systems with real retrieval (e.g. Mem0, MemInsight, Supermemory reach Recall 20–28) still sit at *SC* ≈ 0 on essentially every backbone — the recall-vs-compliance gap is visible cell by cell, not just in the aggregate. (iii) *Backbone sensitivity*. Where a system has a non-zero SC it is usually concentrated in one or two backbones rather than spread evenly, which is why the main table reports both a mean and a max: the max names the best single backbone, and a large mean–max gap flags a system that works only with a particular model. Reading down the AMQ column against SC also makes the diagnostic nature of AMQ concrete — AMQ stays in the 20s–30s even where SC is 0.

I Case Studies: Why Systems Fail

The aggregate numbers in the main-paper results table say *that* every system collapses on STRICTCORE; the ten cases in this section say *why*, one concrete query at a time. We selected them to span the failure taxonomy rather than to be representative of average difficulty, and each is reproducible from the released audit logs: we give the exact `case_id` so a reader can pull the full session transcript, the retrieved-memory trace, and the judge output. Every field shown is taken verbatim from the strict-release audit shards: prompts and contract requirements come directly from the released `query.prompt` and `expected_behavior`, and scores, responses, and activation counts are the recorded per-query values, trimmed only for length.

How to read a card. Every card is one evaluated query with a coloured tag naming its failure type and a provenance line (system / backbone / domain and probe). The upper block is *what the benchmark asked*: QUERY is the verbatim final prompt; SETUP summarises the five-session, thirty-turn history the system had already ingested; crucially, that history is not benign, it deliberately plants an *update* (a fact is revised), a *deletion* (a fact is retracted), and *cross-workspace distractors* (look-alike facts from another scope), so the final prompt is short only because the hard part is deciding which of the accumulated memories are still admissible; MUST USE (✓) and MUST NOT (✗) are the contract’s positive and negative requirements. The lower block is *what happened*: ANSWERED is the system’s real response, SCORES gives Recall / Task / Safety / AMQ plus how many forbidden vs. required memories were activated, and WHY is the one-line diagnosis. The cases fall into two regimes.

Regime A: Retrieved, then non-compliant

These systems expose an activation trace and pull real memories, yet bind superseded, deleted, or out-of-scope units into the answer. High recall does not become contract compliance. These are the most informative failures in the study, because they decouple retrieval from compliance: the system *does* surface relevant memory (sometimes with recall as high as 50%) yet still scores zero on STRICTCORE because it binds a superseded value, an out-of-scope fact, or a restricted secret into the answer. A recall-only leaderboard would credit these systems; AUTOMEMORYBENCH does not, because using the wrong memory is a contract violation regardless of how much right memory was also retrieved.

Case reading. This failure cannot be diagnosed from recall alone. The system retrieves two of the eight required units, but it also activates two forbidden cross-workspace units and binds them into the response. The positive evidence therefore does not partially compensate for the scope violation: task success and safety both remain zero. The example isolates the role of the negative contract, which asks not only whether relevant evidence was found, but whether every memory that influenced the answer belonged to the authorized workspace and remained valid at query time.

Returning those look-alikes is not harmless extra context: it can change the argument supplied to the CRM call. The separate tool probe therefore turns an otherwise fluent memory summary into a testable execution error and shows why precision over admissible state matters alongside evidence coverage.

Regime B: Safe only by withholding

These systems keep safety high by declining to answer or by discarding context. They never violate the contract because they never use memory, so they also solve nothing. The tell is the score signature: Safety = 100, AMQ ≈ 35, STRICTCORE = 0, with an empty or near-empty activation trace. Because AMQ weights safety heavily and safety is trivially satisfied

by never touching a forbidden memory, these systems look mediocre-to-decent on the composite while contributing nothing to the memory-required task: the single clearest reason we report AMQ as a diagnostic column only and rank on STRICTCORE. The variants below differ only in *how* the system avoids committing: explicit abstention, a [no-context] token, narrated forgetting, or a fluent but off-contract answer.

Discussion

A two-failure-mode taxonomy. The ten cases partition cleanly into two mutually exclusive ways to fail the contract. Regime A (*use the wrong memory*) covers unauthorized cross-scope recall, superseded-value binding, governance breaches, and distractor capture: retrieval succeeds but an inadmissible memory is bound into the output. Regime B (*use no memory*) covers empty-retrieval abstention, explicit no-context refusal, over-eager forgetting, and confident off-contract answers: the contract is never violated because memory is never used, so the system is safe and useless at once.

The missing quadrant. Placing systems on the two axes the benchmark separates (*does it retrieve the right memory? does it respect the contract?*), Regime A occupies (retrieves, violates), Regime B occupies (does not retrieve, vacuously complies), and the deterministic anchors of the main-paper baselines table fill (retrieves everything, violates on lifecycle). The fourth quadrant, (retrieves the right memory *and* complies), is the one that corresponds to usable agent memory, and no evaluated system reliably reaches it. That empty quadrant, not any single low score, is the finding **AUTOMEMORYBENCH** is built to expose: contract compliance is a capability distinct from recall, and today’s memory systems have the second without the first.

J Supplementary Analysis Figures

This appendix collects the figures supporting the robustness, validity, and scope claims made in the main text. They fall into three groups: (i) metric validity and gameability, (ii) reproducibility and scale, and (iii) measurement scope. All values are on the audit subset unless a panel states public-test.

Metric validity and gameability

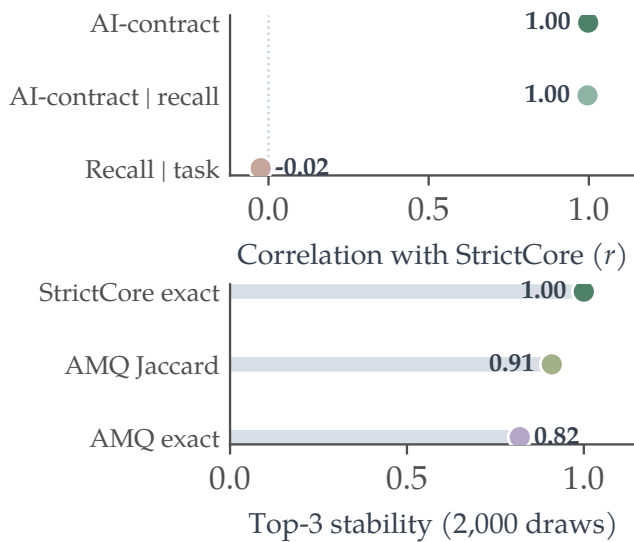


Figure 9: Construct validity and rank stability under 2,000 weight draws.

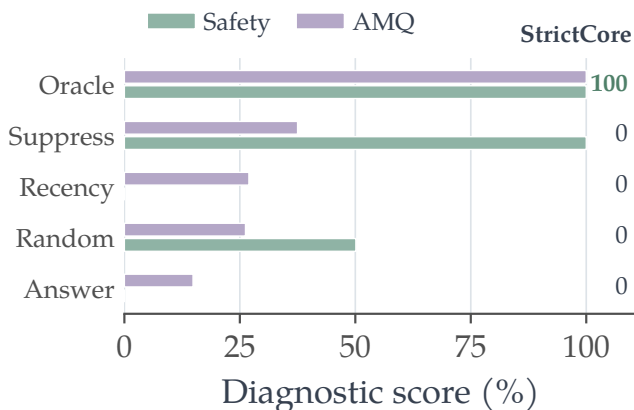


Figure 10: Content-free policies inflate safety or AMQ but score 0 STRICTCORE; oracle scores 100.

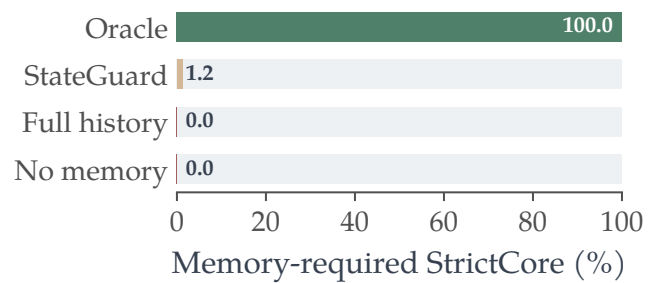


Figure 11: Memory-required STRICTCORE boundary: no-memory scores 0 and oracle scores 100.

Three checks establish that **STRICTCORE** measures what we claim and cannot be trivially gamed. Figure 9 shows convergent and discriminant construct validity: **STRICTCORE**

correlates almost perfectly with an independent AI-contract judgement ($r=1.00$), and that association survives partialling out recall ($r=1.00$), while STRICTCORE’s partial correlation with recall given task is ≈ 0 : it tracks contract compliance, not retrieval. The same panel shows the primary STRICTCORE ranking is invariant to 2,000 metric-weight perturbations (top-3 stability 1.00), whereas the diagnostic AMQ composite is only 0.82/0.91 stable, another reason AMQ is reported as a diagnostic, not a headline. Figure 10 closes the gameability question: four content-free policies (always-suppress, always-answer, random, recency-only) each inflate a different diagnostic (always-suppress reaches safety 100/AMQ 37.5) yet all score STRICTCORE 0, Pareto-dominated by oracle. The guardrail boundary (Figure 11) confirms the floor and ceiling: no-memory scores STRICTCORE 0 and oracle 100 on memory-required probes.

Reproducibility and scale

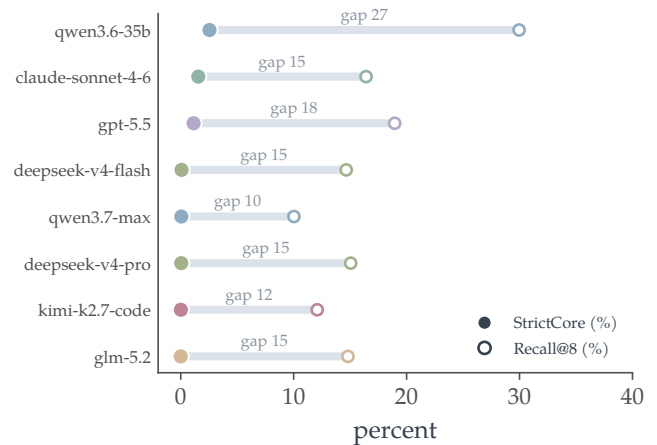


Figure 12: Backbone-level Recall@8 (hollow) and STRICTCORE (filled). Scaling does not close the gap.

Across five generation seeds, all pairwise system-rank correlations equal 1.00, and the headline recall–compliance and evidence–safety gaps retain their sign; these saturated checks are reported numerically rather than plotted. Figure 12 addresses scale directly: across backbone models the recall–compliance gap does not close: even the strongest aggregated model retains a ~ 10 -point gap over tens of thousands of memory-required rows, so the failure is not a small-model artifact.

Measurement scope

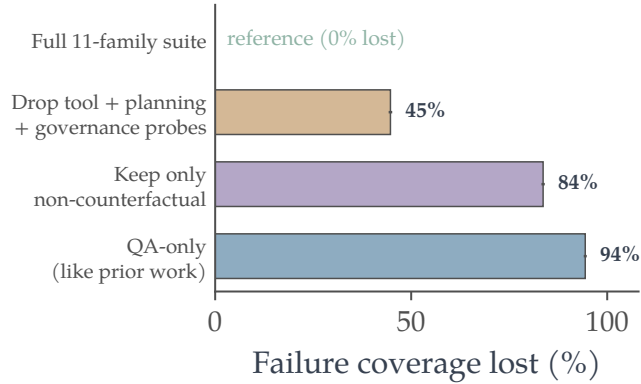


Figure 13: Failure coverage lost under narrower probe suites; QA-only misses 94%.

Figure 13 quantifies what a narrower benchmark would miss. We take the set of contract violations surfaced by the full eleven-family probe suite as the reference (100% failure coverage) and measure how much of that coverage each restricted suite still detects. Restricting to QA-only probes—the regime of much prior long-term-memory work— forfeits 94% of the coverage: almost every lifecycle, authorization, and tool-grounding violation is invisible to a benchmark that only checks final-answer correctness, because a fluent answer built from a stale, deleted, or out-of-scope memory still reads as correct QA. Adding back the lifecycle and update probes but dropping the tool, planning, and governance families recovers most of the answer-level failures yet still

loses 45%, since action-surface and authorization violations only manifest when memory state must control a structured tool argument or respect a role boundary. The gap between the two bars isolates precisely the failure modes that motivate AUTOMEMORYBENCH: they are not detectable by scaling up a QA benchmark, only by probing the negative and action halves of the memory contract directly.

Design implication. The ablation is cumulative rather than a comparison among interchangeable probe families. Removing tool, planning, and governance probes already discards nearly half of the observed failure surface; removing counterfactual probes discards most of it; retaining QA alone leaves only a small residual. Consequently, the eleven-family suite is not breadth added for its own sake. Each retained family tests a distinct place where memory can affect behavior, and the sharp losses show that answer-only evaluation cannot stand in for those checks. This is also why the public release preserves probe-family labels: users can report a full score while auditing which behavioral surfaces contribute to it. Results from a restricted surface should therefore be named explicitly rather than presented as a substitute for the complete benchmark. In particular, a strong QA-only result establishes answer recovery on that slice; it does not establish update handling, authorization compliance, or safe tool use. Keeping that distinction visible makes both positive and negative comparisons reproducible without collapsing materially different evaluation scopes.

Real-System Matrix: Additional Views

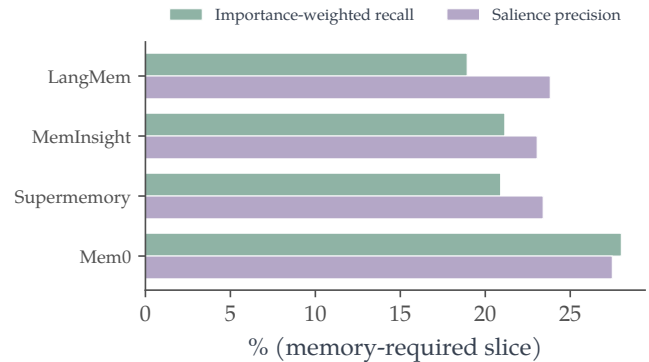


Figure 14: Memory-importance metrics. Only the four systems reporting precision are shown.

Figure 14 expands the 30-system $\times$ 8-backbone matrix (the main-paper results table) with memory-importance metrics computed from the same audit-subset scores. Importance-weighted recall re-weights required memories by their gold importance so that missing a high-importance fact costs more than missing a peripheral one, and salience precision measures the fraction of the system’s activated memories that are actually high-salience required units rather than padding. Only the four systems that expose a genuine activation trace with non-trivial retrieval (Mem0, MemInsight, Supermemory, LangMem) can be scored on these metrics at all; the no-trace anchors are 0 by construction and are omitted. Even these four reach only ~ 20 – 28% on both metrics, and crucially the two bars remain close within each system. Thus, the systems that recover more importance-weighted evidence do not obtain a corresponding concentration of high-salience units. This rules out a charitable reading of the near-zero STRICTCORE scores in which a system reliably retrieves the important memories and misses only trivia. The compliance gap persists when required evidence is weighted by its downstream importance rather than counted uniformly.

Reporting implication. These metrics complement rather than replace the contract gate. Importance weighting distinguishes consequential required evidence from peripheral evidence, while salience precision reveals whether an activation trace is selective. Neither metric checks whether prohibited memory influenced the answer, so a system can improve either bar without becoming contract-compliant. We therefore report both as retrieval diagnostics and retain STRICTCORE as the primary end-to-end measure. Together, the views separate three questions that a single recall number conflates: whether required evidence was found, whether the retrieved evidence was salient, and whether the resulting behavior respected the current memory contract. Trace availability is itself a reporting boundary. A zero produced because no activation trace exists is not evidence that the system retrieved nothing, and it must not be ranked against an observed low precision value. For that reason, Figure 14 visualizes only systems with measurable, non-trivial traces, while the full matrix records trace coverage separately. This keeps instrumentation availability distinct from behavioral performance.
